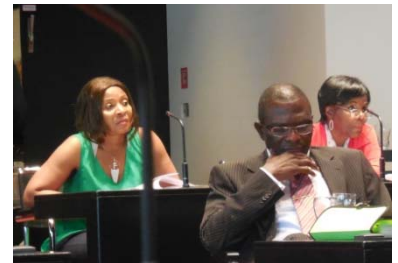
GAIN TACTICAL INSIGHTS AND SHARE YOUR EXPERIENCES

IMMIGRATION FORMALITIES

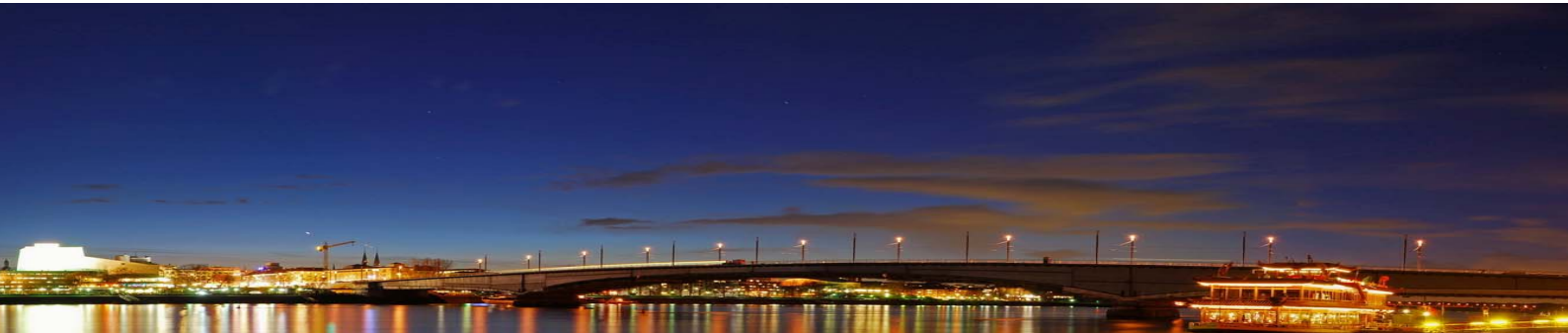

Participants who are not citizens of Schengen countries, or countries which does not have visa waiver agreement with Germany, must apply for visas from the German Embassies or Consulates in their country of origin. b. As a rule, missions require between two and ten working days to decide on an application for a short-stay visa. However, during the peak travel season there may be a waiting period for making the application to the German mission. Applicants are therefore advised to submit their applications minimum three weeks before time.
